Message from the Director



Dear DMH Employee,

By now, you are aware that DMH submitted its report to the Council on the future of the DC CSA. The report articulates a major redesign of the public mental health system which we believe will increase the number

of individuals served and offer a wider range of mental health services. Under the redesign, the government will no longer provide direct services through the DC CSA. I cannot overemphasize that this decision is no reflection on the many dedicated employees who work there. Rather, we have concluded that services can be provided more efficiently by the private provider network while at the same time expanding the range of services to more people.

I am committed to working with existing staff to minimize the impact of this change. I have directed the Human Resources office to start job placement services now. The first place we will look is vacant positions right here within DMH at the Hospital and at the Authority. We are now matching qualified employees with positions and they will be automatically referred for consideration and hiring unless a written justification is given for a more qualified candidate. And, we are working with our sister agencies that have comparable positions and identifying positions outside government.

I have set up a project management office and a number of workgroups to ensure consumers are properly involved in selecting a new provider and to manage all other aspects of the transition. I want to again commend **Juanita Price** and the **DC CSA staff** for their continued focus on patient care during this time.

A Big Step Closer to Olmstead Plan

The Office of Consumer and Family Affairs held a conference with consumers and their family members, advocates and providers on September 23 to engage consumers about Olmstead planning and inform them of their rights.

The DC Office of Disability Rights is conducting a year long process to develop a plan—called the Olmstead Plan—to comply with a 1999 Supreme Court decision in Olmstead v. L.C. that states could not legally require people with disabilities to remain institutionalized in order to receive health care services.

"It's important for consumers to know their rights so they can be active, informed participants in discharge planning," said **Vivi Smith**, Director of the Office of Consumer and Family Affairs. The Ida Mae Campbell Foundation which operates the consumer wellness center and the Consumer Leadership forum participated in the conference.

The availability and quality of community-based services largely determine whether individuals in need of long term care can live in the community instead of an institutional setting such as a nursing facility.
