



Dear DMH Employee,

As we near the end of 2008 and take a moment to reflect on our work during the last year, we can be proud of several initiatives that can make a difference in the quality of life for people who receive mental health services.

The urgent care clinic at Superior Court has linked or relinked more than a hundred people to mental health providers which, hopefully, will help keep them out of the criminal justice system revolving door. The new mobile crisis services has attracted a topnotch team of mental health professionals and created excitement in the community. We are confident that the new crisis service for children will help minimize disruption in the lives of foster children.

Construction began on two new DMH housing projects which will help us meet the growing need for supportive housing. The long awaited renovation at CPEP is nearly complete and we are looking forward to the additional stabilization beds to help reduce the need for hospitalizations. And, at Saint Elizabeths, the reforms underway there are creating a culture of person centered treatment and accountability, and the magnificent new hospital building which is nearly 80% complete will provide a physical environment that promotes healing and recovery.

At the same time, we continue to try to do what we do every day even better. An energized, efficient Office of Accountability has put in place a high level of auditing and monitoring. These are all good signs that together we are building a more robust mental health system.

On the other hand, the economic downturn is affecting the District's budget, and, in turn, will decrease funds available for mental health services. While difficult, the closure of the DC CSA will provide savings that can increase the number of people eligible to be served and expand the range of services. We are planning to submit the implementation plan to the Council on December 31. I encourage you to share your comments with me at steve.baron@dc.gov.


Dr. Bernie Arons appointed Medical Director at Saint Elizabeths

Dr. Bernie Arons, a nationally recognized mental health advocate, administrator and professor, rejoins the staff of Saint Elizabeths Hospital as the Director of Medical Affairs.

"We are honored to have Dr. Arons back at Saint Elizabeths. His experience and expertise in the field of mental health adds a wealthy magnitude of knowledge to our team of talented professionals," said **Dr. Patrick Canavan**, CEO, at a welcome ceremony held for Dr. Arons.

Dr. Arons previously served in a number of positions at Saint Elizabeths, including Chief Clinical Advisor. He has held executive management positions both in the government and the private sector. While he was director, the Center for Mental Health Services at SAMHSA became a leading voice on mental health issues—from studies on parity in mental health coverage to initiatives on school violence, under his leadership. As Senior Science Advisor to the Director at NIH, he provided direction for the country on improving mental health services and mental health financing.

Dr. Arons worked closely with former Surgeon General David Satcher to publish the first-ever Surgeon General's Report on Mental Health. He also served as mental health and substance abuse advisor to Mrs. Tipper Gore and co- chaired with her the Mental Health and Substance Abuse Working Group for the President's Task Force on National Health Reform.

Dr. Arons received his bachelors degree with honors from Oberlin College and the Doctor of Medicine degree from Case Western Reserve University School of Medicine. He also is a Clinical Professor of Psychiatry at the Georgetown University School of Medicine, The George Washington University School of Medicine, and Howard University. He is an Adjunct Professor of Psychiatry at the Dartmouth College Medical School.

Human Resources News: Open Enrollment Ends December 8

Open Enrollment Season ends on Monday, December 8, 2008. This week is the last opportunity for District government employees under both the Federal and District health benefits programs to select, change or update benefits for the 2009 plan year.

Except under limited circumstances, this is the only time that employees can choose a health care plan, enroll in the short-term disability insurance program, and set up flexible spending accounts.

And, for this year only, District employee benefits participants can change life insurance elections. HR encourages all eligible employees to use ESS (Employee Self Service) to make open enrollment selections and changes. ESS is fast, easy, convenient and paperless.

His department also organizes the annual Field Day held in conjunction with the popular summer concert series. He says he enjoys his job and looks forward to coming every day. Plus, he has the satisfaction of knowing that his job makes a difference in the lives of the patients.
